- c. **ASG Retreat:** Members voted to approve expenses for the summer leadership retreat on August 15th and August 16th, 2023.

- i. Members reviewed the retreat options and approved of an August 15<sup>th</sup> San Elijo campus training with breakfast and lunch and an August 16<sup>th</sup> field trip to San Diego for a tour of Chicano Park, lunch, followed by an optional beach outing with snacks.
- ii. Budget: \$2,500 for the retreat expenses with any unused funds returning to the ASG.

- Most of the cost is food
- \$1,350 (8/15 will include breakfast and lunch) and will accommodate 30 people

- \$350 service charge for tour
  - \$540 for lunch per diem
  - \$260 for the beach/sunset watch gathering for food, activities, and coolers. (approx. 5 pm)
- iii. Other retreat training suggested included learning about campus resources, participating in the UCSD Challenge Course, an overnight retreat, how to share about ASG, and how to balance being a student and leader.
