#### VIII. 5-Year Construction Plan

Dajani reviewed the 5-year construction plan budget revisions that the board of trustees approved at their June 2025 meeting. All MM funded additions to projects are offset by savings from closed out projects.

### Changes include:

- CLC Solar Project Increase of \$632K from MM savings to meet additional DSA requirements
- B3000 Series Increase of \$100K from district funding for contractor parking.
- B1000 Reno \$141K partial MM project savings.
- Lot 5A \$905K final MM project savings.
- OC4700 Increase of \$950K from MM project savings to meet cost escalation and design improvements.
- B1200 Reno \$2.3M partial MM project savings.
- North Storm Drain Realignment of expenditures to match actuals
- OC Stair Removal and Bridge Repair \$1.5M savings from MM project due to costs being covered by insurance claim from bridge accident.
- Security Infrastructure \$564K increase from MM savings to meet additional scope.
- OC Swing Space \$927K increase from MM savings for T200s lease extension.
- OC Solar Project \$861K increase from MM savings to meet additional DSA requirements.
- SAN400 Reno Realignment of expenditures to match actuals
- SAN100 Reno \$26K final MM project savings
- SAN Central Quad \$3.7K final MM project savings
- SAN Misc Enhancements \$246K final MM project savings
- SAN Path of Travel Update \$94K final MM project savings

- OC3000 Series Renovation Construction: \$69.3M. Structural framing, MEP rough-in, steel decking and roofing in progress. Installation of Densglass and waterproofing on the exterior has commenced.
- Solar Project DSA: \$19.7M. Installation is underway with completion in Spring 2026. The first & second phases in parking lots 5A and 4C are complete. Contractor started phase 3 at 5A August 11th.
- OC4500 Science Renovation Design: \$35.5M. DSA review is underway with construction planned to begin Spring 2026.
- OC4700 Professional Development Project Design: \$4.7M. DSA review is underway with construction planned to begin Summer 2026.
- Wayfinding and Signage Design: \$4.3M. The design team is working with DSA to gather initial review feedback and will then proceed with the next stages of design development. Extensive pre-construction planning to ensure a smooth rollout of new sign types. Construction is planned for Summer 2026.
