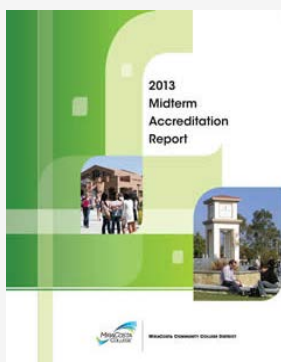
Substantive Change Proposal for Bachelor Degree - Under Construction

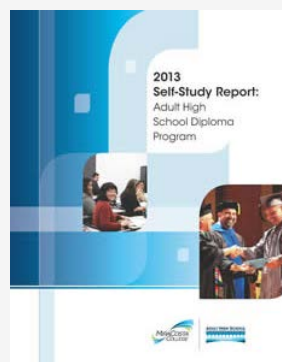


Substantive Change Proposal for Distance Education

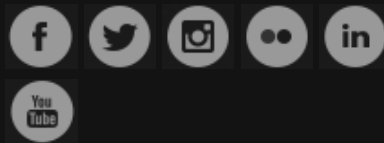
