After MiraCosta College processes your application (typically within two business days), you will receive an email with information about **SURF**, our online registration system accessible at **surf.miracosta.edu**. You must log in and set up a password. Then you'll use **SURF** to register for your classes. Visit **miracosta.edu/admissions** for more information.

Understanding Priority Registration Groups

Each student is assigned an online registration date and time. MiraCosta College sets registration priorities based on guidance from Title 5 Section 58108. Find the registration group (A, B, C, D, E, F) to which you belong on pages 12–14, and then reference the chart on page 14 to find your exact registration date.

Group A:

Special populations

Students in this group include:

- A member of the Armed Forces of the United States who is also a resident of California.§
- A Veteran of the Armed Forces of the United States who is also a resident of California.[†]
- A student parent who has a child or children under 18 years of age who will receive more than half of their support from that student.[‡]
- A foster youth or former foster youth who is not older than 25 years of age at the commencement of the academic year.[‡]
- Unhoused/homeless youth or former unhoused/homeless youth under 25 years of age at the commencement of the academic year.
- ✓ EOPS, CalWORKs/Tribal TANF, and Student Accessibility Services (SAS).

Group A: Special populations (CONTINUED)

To receive and maintain priority registration, new and continuing Group A students must do the following:

- Complete onboarding steps (placement process, orientation and advisement);
- Veterans and active-duty military must complete a comprehensive education plan within their first semester at MiraCosta College. Others in Group A must complete an education plan within two semesters;
- Maintain good academic standing with at least a 2.0 GPA and complete at least 50 percent of enrolled units (excludes unhoused/homeless youth, former foster youth, and foster youth); and
- 🥒 Not exceed 100 degree-applicable units. (Students in the Bachelor of Science in Biomanufacturing degree program, homeless youth, foster youth, former foster youth, and SAS are exempt from the 100 unit limitation).

Group B:

All other matriculated continuing, new, and returning students

Students in this group include:

🥒 Athletes, International Students, BS Biomanufacturing Program, Puente Program, and students (continuing, new, and returning) who have completed the onboarding steps.

To receive and maintain priority registration, Group B students must do the following:

- Complete onboarding steps (placement process, orientation and advisement);
- Complete an education plan prior to completion of 15 units or third semester, whichever comes first;
- Maintain good academic standing with a 2.0 GPA or better;
- Complete at least 50 percent of enrolled units; and
- 🥟 Not exceed 100 degree-applicable units. (Students in the Bachelor of Science in Biomanufacturing degree program and unhoused/homeless youth, foster youth, former foster youth, and SAS are exempt from the 100 unit limitation).

Group C:

Continuing, new, and returning students who have not completed the onboarding steps

All students who have not completed the onboarding steps and students who have already earned a bachelor's degree.

Students on academic or progress notice

Any student who has been on notice for at least two consecutive semesters, including students on academic notice (GPA-based) or progress notice (based on the percentage of courses completed with an evaluative grade).

Group E:

Students with over 100 units

Students who have completed more than 100 units with a grade of A, B, C, D, F, P, or NP. Courses that are considered basic skills will not be counted toward the completion of units in this category although they will count toward accumulation of units in Groups B and C.

Group F:

Concurrently enrolled high school students

Concurrently enrolled high school students are restricted from registering early and may only register at the end of the registration period.

Online Registration Times

All students must check **SURF** at **surf.miracosta.edu** to find their online registration time.

The number of units you have completed at MiraCosta College determines your registration priority. For Groups B and C, this includes all courses completed, including basic skills and ESL classes. Students who have completed 100.5 units or more in degree-applicable courses will be assigned to Group E.

Online registration times are assigned randomly within each group and start at 8 a.m. for Groups A-F. You may register on your assigned online registration date and time, or any time after throughout the registration period.
