

# **Early College Credit Form**

This form is for high school students who have completed the 8<sup>th</sup> grade or are 15 years of age or older.

#### The following conditions are associated with admission as an Early College Credit student:

- Only one form is required for the entire duration of your attendance at MiraCosta College while in high school.
- The course content is not altered, is intended for adults and students may be exposed to discussions, readings, and visual materials of mature nature.
- The student is treated as an adult and is expected to act in a mature manner in the classroom.
- Grades earned at MiraCosta College are recorded on the student's permanent academic record at the college.
- Students can enroll up to a maximum of 11 units per fall/spring term and 8 units per summer session; exceptions are made for OUSD CCAP Dual Enrollment students who may enroll in up to a maximum of 15 units per fall/spring term or 9 units per summer session. #### Where to submit your form:

- Adobe e-Sign Form: Admissions & Records will receive the form once all parties have signed.
- Print and Sign Form: Email the completed form to <u>dualenroll@miracosta.edu</u>.
- Once the form is processed (usually in 1-3 business days), Adobe e-Sign will send an automated email to everyone confirming that the form has been processed. If the form was emailed, the student will receive confirmation from <u>dualenroll@miracosta.edu</u>.

# **Tuition and Fees**

- Tuition and fees are waived; however, F-1 students are required to pay all applicable fees.
- CCAP OUSD/Dual Enrollment Students: students taking classes at their high school will have books and supplies provided by their high school.
- Concurrent Enrollment Students: are responsible for purchasing material fees, books, and supplies related to their enrolled courses.

# Transcripts

- At the end of the semester, official MiraCosta College transcripts can be ordered through Parchment at <u>miracosta.edu/transcripts</u>.
  The first two transcripts ever requested are free; thereafter, transcripts will be \$7.00 per request.

## **Priority Registration**

- According to State Education Code 76001, early college credit high school students must be assigned the lowest registration priority to prevent displacing regularly admitted students enrolling each term; the following exceptions are made for OUSD CCAP Dual Enrollment students:
  - The district may give registration priority to students who need a community college course that is required for their CCAP Dual Enrollment program. This registration priority is the same as what students attending a middle college high school receive according to Education Code Section 76001. Credits earned in line with a CCAP program may help determine a student's registration priority at a community college.

# **Rights and Responsibilities of Students**

- Students must complete an online <u>Admissions Application</u> through CCCApply.
  - An application is not required if a student was enrolled the previous semester, however if a student does not enroll in courses for two consecutive Fall/Spring semesters, they will need to submit a new admissions application.
- A student under 18 years old must obtain signatures from both a parent/guardian and the high school principal or designee.
  - Students 18 years or older DO NOT need a parent/guardian signature and must only obtain a signature from their high school principal or designee.
- Students registered in MiraCosta College courses are expected to adhere to MiraCosta College policies on student responsibilities, standards, and conduct at all times. Student rights and responsibilities are outlined in the <u>MiraCosta College Catalog</u> and includes course information and college policies such as grading, course repetition, enrollment procedures and course transfer. All students are directed to read the sections on Academic Standards and Policies, Student Support Programs and Services, Student Rights and Responsibilities and Standards of Conduct.

# **Information for Private and Home Schools**

## **Private High School Students**

- California Education Code Sections 48800 and 76001(a) require that high school students from private high schools may register for classes through concurrent enrollment upon petition of the parent. Placement into college credit classes may be determined by the private high school representative.
- Recommendations from private high school principals will only be accepted if the school has filed a Private School Affidavit with the <u>California Department of Education</u>.
- If the private school isn't listed as active on the California Department of Education website, the student will need to send a copy of their Private School Affidavit for the current school year to <u>dualenroll@miracosta.edu</u>.

#### **Home-School Students**

- Home-schooled students must show proof that they are registered as a private school by providing a Private School Affidavit for the current school year **OR** they can get approval from the public high school they would normally attend. The local high school must agree that home-schooling counts as valid school attendance and decides if the student has done enough coursework to be ready for college classes.
- Home school students must email their Private School Affidavit to <u>dualenroll@miracosta.edu</u>.

# Early College Credit Options Available to Students

## **Concurrent Enrollment**

Offers high school students the chance to take college courses at MiraCosta College (in-person, online, or hybrid) and earn college credit.

- Eligible HS students: All high school students
- The following conditions are associated with admission as a Concurrent Enrollment student:

- o Students are responsible for registering themselves for classes each term.
- Approval does not guarantee enrollment. If the class is filled, students will need to obtain a permission number from the instructor once the term begins.
- o Students are responsible for checking their class schedule in SURF.
- Students accept full responsibility for the grade they will receive or for dropping a class they will not attend.

## CCAP Dual Enrollment (Courses taught at OUSD)

#### CCAP Dual Enrollment (Courses taught at OUSD)

Earn college credit and meet HS graduation requirements by taking MiraCosta College classes offered at your high school campus or online.

- Students must contact their high school counselor before completing this form.
- Eligible High School Students: El Camino High School, Oceanside High School, and Surfside Educational Academy.
- Approval does not guarantee enrollment. If the class is filled, students will need to obtain a permission number from the instructor once the term begins.
- Students are responsible for checking their class schedule in SURF.
- Students accept full responsibility for the grade they will receive or for dropping a class they will not attend.
- MiraCosta College is authorized to release academic records and official grades to your high school registrar, counselor, or designee and you may be eligible to receive course credit toward your high school completion.
- By signing the Early College Credit Form, the student, parent or guardian, High School principal or designee, and College designee are certifying they're in compliance with the requirements listed in the MiraCosta College Administrative Procedure 5011: Admissions and Concurrent Enrollment.

## Dual Enrollment (Courses taught at CUSD and SDUHSD)

Earn college credit and meet HS graduation requirements by taking MiraCosta College classes offered at your high school campus or online.

- Students must contact their high school counselor before completing this form.
- Eligible HS students: Carlsbad High School, Sage Creek High School, Canyon Crest Academy, La Costa Canyon, San Dieguito Academy, and Torrey Pines High School.
- The following conditions are associated with admission as a Dual Enrollment student:
  - Approval does not guarantee enrollment. If the class is filled, students will need to obtain a permission number from the instructor once the term begins.
  - Students are responsible for checking their class schedule in SURF.
  - Students accept full responsibility for the grade they will receive or for dropping a class they will not attend.
  - MiraCosta College is authorized to release academic records and official grades to your high school registrar, counselor, or designee and you may be eligible to receive course credit toward your high school completion.

## **Cathedral Catholic High School**

Earn college credit and meet HS graduation requirements by taking MiraCosta College classes offered at your high school campus or online.

- The following conditions are associated with admission as a CCHS Dual Enrollment student:
  - Approval does not guarantee enrollment. If the class is filled, students will need to obtain a permission number from the instructor once the term begins.
